**Board Education: Transportation, Roby Fuller Prairie Du Chien Office**

Roby Fuller gave a presentation on ADRC Transportation programs. Topics included types of transportation programs, who is eligible for rides, types of trips, funding sources, costs and revenues.

Gina Laack outlined the "Find Your Own Ride" program Juneau County is currently starting.

Susan Blodgett talked about the volunteer driver program in Sauk County.

Roxanne Klubertanz-Gerber talked about the volunteer driver program and bus programs in Richland County.

Retiring vehicles and transportation trust funds were discussed.

### **Update from the Field: Prairie Du Chien Office**

Roby Fuller talked about a referral from the Oshkosh Correctional Facility with Dementia who now requires different care. Winnebago County ADRC was able to do a functional screen to determine eligibility for programs. This type of situation is something that could be increasingly common with older adults aging out of the prison system. The challenge in finding placement for these cases will be that individual facilities can set limitation regarding who they admit based on criminal background.
